We serve children and youth (Littles), ages 6-18 years, who are in need of academic assistance and/or are at risk of dropping out of school, lack social skills, and are at-risk of developing delinquency problems such as drug/alcohol use.

Community-Based Mentoring, a core program, offers the opportunity for children and youth (Littles) and their mentors (Bigs) to spend time

together in their local communities. A Big and a Little are matched based on their shared interests and individual child's needs. Bigs meet with their Littles on evenings and weekends to participate to activities such homework help, sharing a meal together, and attending local museums, theaters, and sporting events. During their match outings, filled with conversation and shared activities, Bigs and Littles develop a relationship to help youth manage their everyday challenges of growing up.

SMART Mentoring, (Supporting Math And Reading Through Mentoring) is a School-Based Program. Students, referred by teachers and school counselors, are struggling and/or failing in school, lack social skills, or have problem behaviors such as chronic absenteeism, or skipping classes. SMART Mentoring offers the opportunity for Bigs to meet with their Littles on a school campus or at an after-school site once per week, for 45 - 90 minutes, during the school year. At least 50% of each weekly match meeting is spent on homework help and/or reading together. Their mentoring relationship promotes a positive school experience for the child: constructive peer and adult relationships, a positive attitude and academic success.

Mentor Connections focuses on military-connected students in elementary school grades. Active-duty families move on the average every two to three years. Such frequent transitions can be disruptive to a child's education and social development as well as cause significant stress on the family. Our Mentor Connections program focuses on building resilience in each child, increasing their ability to cope with the stress of parental deployment and frequent moves.

Specially trained mentors (Bigs) meet with their military-connected

Littles weekly at an elementary or middle school campus for 45 minutes to an hour during school hours. Activities may include sharing the lunch meal together, playing board games and participating in outdoor recess activities.

Our Youth Impact Project serves youth ages 15-17 years of age who are currently in a detention facility and who have continued involvement with probation, court services, and his/her school. Big Brothers Big Sisters provides a one-hour program orientation to youth, as well as 10 hours of work readiness skills training. The program focuses on encouraging youth to complete high school or receive their GED, as well as providing them with mentors to help encourage their path to educational and employment success. 94% of Littles are confident they will finish high school. 69% of Littles felt socially accepted by their peers. 99% of Littles avoided risky behaviors. 88% reported doing well in school.
